



DEFINITIONS

The **5 year Earnings Per Share (EPS) growth rate** is the weighted average of earnings per share growth for all securities in the portfolio projected for the past five fiscal years Earnings per share for a company is defined as total earnings divided by shares outstanding. represents the value of the assets of a fund less its liabilities. **Number of holdings** provided are a typical range, not a maximum number.
