## Performance Review

For the month ending November 30, 2024, the Fund I class shares returned 23.91% (net of fees) and the Russell 1000 Growth Index returned 6.49%.

Year to date, the Fund returned 52.55% (net of fees), outperforming the benchmark return of 32.19%.

## Market Review

Large cap growth equities, as measured by Russell 1000 Growth Index, advanced year to date. Utilities, Energy and Communication Services led benchmark gains, while Real Estate, Health Care and Consumer Staples underperformed the benchmark.

## Portfolio Review

In the first half of the year market results were dominated by a few mega cap companies. As a more dovish Federal Reserve started its pivot with a more aggressive rate cut, expectations for further easing grew and a broader range of companies saw stronger results with sentiment toward higher growth equities improving.

YTD Fund outperformance has been driven by favorable stock selection in Consumer Discretionary, Information Technology and Financials. Conversely, stock selection in Health Care and Materials, as well as an average sector underweight position in Information Technology detracted from relative performance.

The fundamentals of our portfolio holdings remain strong despite an uncertain macroeconomic environment. Over the next three years, our companies are expected to grow revenues at 20% versus 17% for the benchmark<sup>1</sup> and 96% of the portfolio is expected to be free cash flow positive or neutral in 2024 (estimated)<sup>2</sup>. We have confidence that our companies are making the right investments to maximize the long-term end game potential of their businesses.

## Outlook

Counterpoint Global looks to own a portfolio of unique companies with diverse business drivers, strong competitive advantages and positioning, and healthy secular growth prospects whose market value we believe can increase significantly over the long-term for underlying fundamental reasons, independent of the macro or market environment. We

find these companies through fundamental research. Our emphasis is on secular growth, and as a result short-term market events are not as meaningful in the stock selection process.

Counterpoint Global believes having a market outlook can be an anchor. We focus on assessing company prospects over a five-year investment horizon. Current portfolio positioning reflects what we believe are the best long-term investment opportunities.

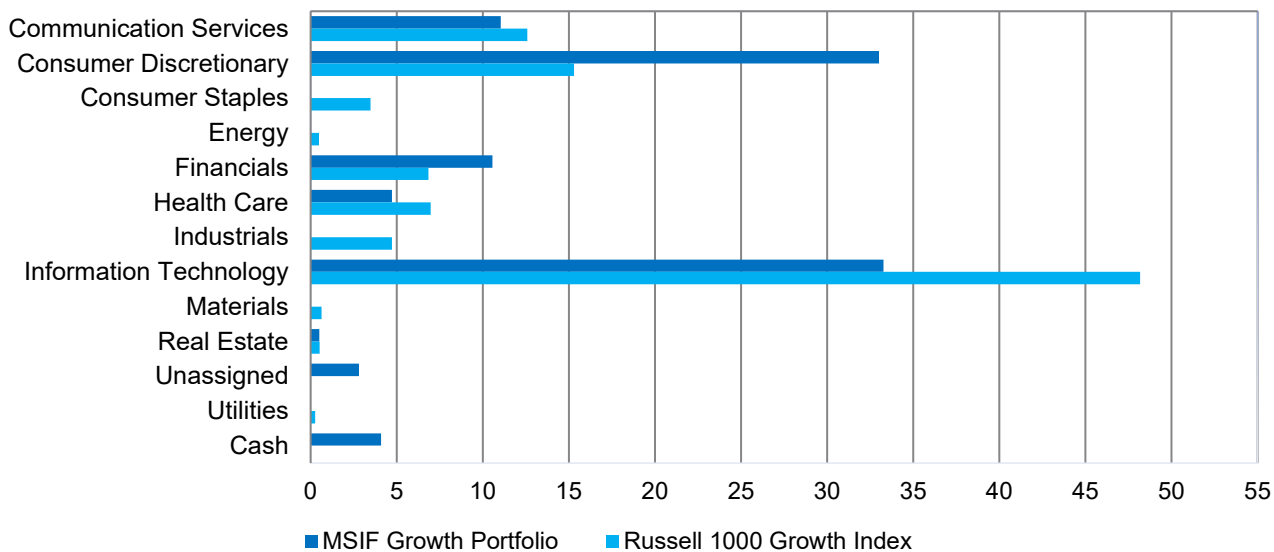
